ARTICLE ONE NAME

The name of the corporation is THE DOTHAN POLICE FOUNDATION, INC.

ARTICLE TWO DURATION; FORMATION

The term of existence of the Corporation is perpetual. The Corporation is formed pursuant to Section 10A-3-1.01 et seq. of the Alabama Nonprofit Corporation Law.

ARTICLE THREE PURPOSES

The objects and purposes of this corporation shall be:

- 1. Exclusively religious, charitable and educational endeavors within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law.
- 2. Notwithstanding any other provision in these Articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from the federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding provision of any future United States Internal Revenue Law.
